

Regular Council October 1, 2019

Meeting came to order with Pledge of Allegiance. Roll call was answered by Cou. Broker, Gwinner, Behrendt, Failor, & Robbins. Cou. Aichholz was absent. Cou. Broker made motion to accept & dispense with reading minutes; 2nd by Cou. Robbins. Accepted by all. Cou. Broker made motion to accept reports; 2nd by Cou. Robbins. Accepted by all. Cou. Behrendt made motion to pay bills; 2nd by Cou. Broker. Accepted by all.

OLD BUSINESS:

Mayor spoke to Denise Plummer from Poggenmeyer. She said underground utilities contract for the sewer/road project had a one-year maintenance warranty for the roads. The time has passed. Cou. Broker will get estimates for the road repair on Chickasaw.

Discussion on Ord. 2019-12 (dock ordinance). Cou. Gwinner said he submitted his thoughts at the last meeting. No one else has submitted any. Cou. Failor thinks we should wait until Cou. Aichholz is here to vote on it. Mayor suggests we table it until all issues are ironed out. She suggests a shoreline committee meeting to work on it.

Cou. Robbins made motion to hire Tristan Homan as part time patrolman; 2nd by Cou. Broker. Accepted by all. Solicitor swore him in.

Mayor said patrolman Zach Tyson has resigned. His last day is October 13. He was hired full time by Sandusky Police Department. Mayor thanks him for his service to Bay View.

The red truck should be done this week. The white truck has new tires and the box has been repaired. Chipping should begin soon.

BGSU wants to put a weather reporting station at the end of the bridge (to be used for algae blooms) Solicitor would like to see a contract.

PUBLIC CONCERNS:
