OLD BUSINESS:

We will continue to search to try to find a service that handles bed tax.

Discussion on Cody Pass. We will get a title search done and then decide on selling it.

NEW BUSINESS:

We had 3<sup>rd</sup> reading of Ord. 2022-10 (accepting updated flood plain maps). Cou. S. Broker made motion to adopt Ord. 2022-10; 2<sup>nd</sup> by Cou. Behrendt. Accepted by all.

Cou. S. Broker made motion to have solicitor prepare a resolution spending up to \$14000 for survey and fence enclosing the storm water pump station area (Fremont Fence), using American Rescue Plan funds; 2<sup>nd</sup> by Cou. K. Broker. Accepted by all.

Cou. Behrendt said we will be having another Independence Day event on July 2<sup>nd</sup>. Golf cart and bike parade, readings, canon, and refreshments.

Mayor said the catfish tournament went well. The village was given \$1300 (half of the buy in fees) for beautification of bay front. Bill Ladley did not attend. Jim Johnson took over. Mayor thanked him. Jim would like to meet with village officials regarding a 2-day festival weekend.

Cou. S. Broker made motion to have solicitor prepare a resolution of necessity for the upcoming 4 mill fire levy renewal; 2<sup>nd</sup> by Cou. Grieger. Accepted by all.

Cou. S. Broker made motion to adopt Res. 2022-03 (authorizing expenditure of up to \$7000 for repair of storm sewer system); 2<sup>nd</sup> by Cou. K. Broker. Accepted by all.

Discussion on sale of surplus equipment. We will try govdeals.com. If that does not work, we will see what we can get for scrap.

FLOOR:

Zoning Inspector asked the purpose of fence around pump station. Mayor said to protect and keep people away from pump station. He also commended volunteers who cleaned up the split tree.
