Regular Council October 4, 2022
Meeting came to order with Pledge of Allegiance. Roll call was answered by Cou. S. Broker, Behrendt, James, K. Broker, \& Grieger. Cou. Aichholz was absent. Cou. S. Broker made motion to accept and dispense with reading minutes; $2^{\text {nd }}$ by Cou. Behrendt. Accepted by all. Cou. S. Broker made motion to accept reports; $2^{\text {nd }}$ by Cou. K. Broker. Accepted by all. Cou. S. Broker made motion to pay bills; $2^{\text {nd }}$ by Cou. Behrendt. Accepted by all.

## NEW BUSINESS:

Cou. S. Broker made motion to hire Hinman Tree Service to remove three trees at the kiddie park for $\$ 5000 ; 2^{\text {nd }}$ by Cou. K. Broker. Accepted by all.

Cou. S. Broker made motion to hire Lake Effect Custom Cooling \& Heating to install LG heating and air conditioning at the hall (with ultra violet capability to make air quality covid resistant) for $\$ 8200 ; 2^{\text {nd }}$ by Cou. K. Broker. Accepted by all.

Cou. S. Broker handed out copies of one estimate for a new building for village vehicles. Cost is about $\$ 98,000$. ( 50 by 72 , not including electricity). There would be ten feet between the new building and fire station. We will discuss further at next meeting with solicitor (regarding advertising, etc.).

Mayor said restrooms at park were vandalized. Franklin Sanitation is coming tomorrow. Mayor thinks maybe we need a new policy where restrooms are only used for shelter rentals. Cou. Behrendt suggests security cameras.

Mayor said someone tried to vandalize the new handicap swing at park. We need to decide how to maintain it. Maybe a fence around it. We could lock it and give keys to people that have need of the handicap swing, Cou. S. Broker made motion to purchase cameras and signs for the handicap area at park for not more than $\$ 200 ; 2^{\text {nd }}$ by Cou. Behrendt. Accepted by all.

## PUBLIC CONCERNS:

Police Chief would like to hire an additional patrolman. Council said fine.

Daryl Pasek thinks we should put up the building as soon as possible. He is afraid we won't do it if we put it off. He also thinks we should go with the bigger one. Mayor said we are going to build it, we are just being cautious.

Lance Drossman thinks the buildings at the fire station should be connected.
Cou. S. Broker made motion to adjourn; $2^{\text {nd }}$ by Cou. K. Broker.
