## **OLD BUSINESS:**

Cou. Broker made motion to place new LED sign in front of the village hall, by the flagpole; 2<sup>nd</sup> by Cou. Robbins. Accepted by all. We will put brick and landscaping around it in the future.

## **NEW BUSINESS:**

Cou. James made motion to have a fall cleanup day for the village residents on Nov. 14<sup>th</sup>, paying up to \$525 for a dumpster; 2<sup>nd</sup> by Cou. Broker. Accepted by all.

Cou. James made motion to allow a clambake at the park, using a fire pit; 2<sup>nd</sup> by Cou. Behrendt. Accepted by all. (Fire chief has approved)

Cou. Behrendt said the street dept. would like to plant some of the saplings she has at the park. She has prepared another village newsletter. Mayor thanks her.

Fire Chief said the new squad will be delivered tomorrow and should be in service within a week. Chief said our life pack had a catastrophic failure and is being shipped to Physio. It needs to be re-programed and re-calibrated. A rental one will be here tomorrow. Cost is \$240 per month, plus shipping. We should only need it for one month.

Laptops are ready for virtual meetings, but we still need to get set up with zoom. We will have next meeting on Wed. November 4, due to elections at fire station. Cou.
