Cou. K. Broker made motion to adopt Res. 2024-04 (accepting levies and rates from budget commission); 2nd by Cou. S. Broker. Accepted by all.

Cou. Drossman made motion to purchase three signs for "no fishing from 7pm to 7am along bayfront" not to exceed \$400; 2nd by Cou. S. Broker. Roll call was Cou. K. Broker-yes, Cou. S. Broker-yes, Cou. James-abstain, Cou. Grieger-yes, and Cou. Drossman-yes. Motion passes.

Solicitor put ad in newspaper regarding public hearing for zoning book changes (setbacks and transient rentals). Meeting will be November 5th at 6:30 at village hall.
